

International Warranty

SUBJECT: LIMITED WARRANTY

LIMITED WARRANTY POLICY ON STEAMBATH STEAM GENERATORS PURCHASED FROM STEAMIST CO., INC.

A. Limited Warranty for Residential (Family) Units

These units are defined as steambath generators which are installed in homes, apartments and dwellings. These units are used an average of one hour per day.

Steamist hereby warrants that its Steamist (residential) steam generators are free from all defects in workmanship or materials for Two (2) years from the receipt of shipment to the Distributor.

This Warranty is void of any of the following should occur:

- 1. If the product is used for anything other than a residential steambath installation or used in commercial application.
- If the serial number has been altered or removed.
- 3. If the product is modified in any manner which Steamist concludes, after inspection, affects the reliability of the product.
- 4. If the product has been repaired or serviced by anyone not specifically designated and authorized by Steamist.
- 5. If the product is damaged because it is not operated or installed in accordance with supplied instructions.
- 6. If the product is damaged during shipment.

The Distributor's sole remedy shall be to repair or replace as is expressed herein and under no circumstances shall Steamist be liable for any loss or damage, be it direct or consequential, arising out of the use or inability to use this product.

If Warranty Parts are required they will be shipped EX Works from Steamist Inc, USA Location.

The Customer and or Distributor are required to Pay All Shipping, Tax, Duties and Freight.



B. Limited Warranty for Residential Units Equipped with Auto Drain Valve when used for Light Commercial Use

These units can run up to 6 hours per day and should not be used for health clubs or any other commercial installations when they require to run up to 6 hours per day. These steambath generators are constructed the same as the residential units referenced above, <u>except</u> they are used on a limited basis in commercial installations.

Steamist hereby warrants that its Steamist (Residential) generators are free from all defects of workmanship and materials for 6 months from receipt of shipment to the Distributor.

The Warranty is void if any of the following should occur:

- 1. If the product is used for anything other than a steambath application.
- 2 If the heating element fails or is burnt out due to excessive mineral build-up in the Stainless Steel Tank (water reservoir).
- 3. If the serial number has been altered or removed.
- 4. If the product is modified in any manner which Steamist concludes after inspection, affects the reliability of the product.
- 5. If the product has been repaired or serviced by anyone not specifically designated and authorized by Steamist.
- 6. If the product is damaged because it is not operated or installed in accordance with supplied instructions.
- 7. If the product is damaged during shipment.

The Distributor's sole remedy shall be repair or replace as is expressed herein and under no circumstances shall Steamist be liable for any loss or damage, be it direct or consequential arising out of the use or inability to use this product.

If Warranty Parts are required they will be shipped EX Works from Steamist Inc, USA Location.

The Customer and or Distributor are required to Pay All Shipping, Tax, Duties and Freight.



C. Limited Warranty for Commercial (Business) Units

These units are defined as steambath generators which are installed in health clubs, spas, beauty parlors, hotels and leisure places.

Steamist hereby warrants that its Steamist (Commercial) generators are free from all defects of workmanship and materials for One Year from the date of shipment to the Distributor.

The Warranty is void if any of the following should occur:

- 1. If the product is used for anything other than a steambath application.
- 2. If the heating element fails or is burnt out due to excessive mineral build-up in the Stainless Steel Tank (water reservoir).
- 3. If the serial number has been altered or removed.
- 4. If the product is modified in any manner which Steamist concludes after inspection, affects the reliability of the product.
- 5. If the product has been repaired or serviced by anyone not specifically designated and authorized by Steamist.
- 6. If the product is damaged because it is not operated or installed in accordance with supplied instructions.
- 7. If the product is damaged during shipment.

The Distributor's sole remedy shall be repair or replace as is expressed herein and under no circumstances shall Steamist be liable for any loss or damage, be it direct or consequential, arising out of the use or inability to use this product.

If Warranty Parts are required they will be shipped EX Works from Steamist Inc, USA Location.
